Section 210.254 RSMo requires notification that background checks have been conducted under the provisions of section 210.1080 RSMo.  Section 210.1080 RSMo specifies criminal background checks for child care staff members. The requirements for religious organizations operating a child care facility are as follows:  Facilities operated by a religious organization that receive federal funds for providing care for children must have qualifying background screening results for child care staff members as defined in 210.1080.1(1) RSMo. Facilities operated by a religious organization and that do not receive federal funds for providing care for children are not required to have qualifying background screening results for all child care staff members pursuant to 210.1080.9 RSMo. Child care staff members of facilities operated by a religious organization that receive federal funds for providing care for children, with disqualifying background screening results are prohibited from being on the premises during child care hours. Facilities operated by a religious organization that receive federal funds for providing care for children, must request criminal background checks for child care staff members every 5 years, as defined in 210.1080.1(1) RSMo. Problem solving techniques are taught and practiced to build student capacity for coping, working with a group of peers and working toward positive outcomes even in the the face of adversity and disappointment. Food based consequences, "time-out", and physical reprimands are not used at the facility.

Shirlee Green Preschool follows constructivist approaches in project-based learning and experiential education at all ages. Academic benchmarks are set and worked on throughout the year and shared with parents. Shared goals are aligned with latest cognitive theory within constructivist learning.
